CALL FOR PAPERS

Education is a term which plays a very important role in the development of any country and when all the countries are trying to achieve it the one who provides excellence wins the battle. To make ones presence felt at international level institutes have to take various initiatives to keep pace with rest of the world. It is aimed to achieve excellence as globalization has opened the doors wide for the entry of individuals of different countries to different locations and they can survive in the changing environment only if they provide excellence through various means and ways. Excellence is valuable quality; that by which any one excels or is eminent; a virtue. Higher education contributes factors from leading scholars of the world to solve various problems of students, planners, administrators etc.

In National Education Policy, 2019, the Committee noted that the current higher education system has multiple regulators with overlapping mandates. This reduces the autonomy of higher educational institutions and creates an environment of dependency and centralized decision making. Therefore, it proposes setting up the National Higher Education Regulatory Authority (NHERA). This independent authority would replace the existing individual regulators in higher education, including professional and vocational education. This implies that the role of all professional councils such as AICTE and the Bar Council of India would be limited to setting standards for professional practice. Also, the role of the University Grants Commission (UGC) will be limited to providing grants to higher educational institutions. Currently, higher educational institutions can only be set up by Parliament or state legislatures. The draft Policy proposes that these institutions could be allowed to be set up through a Higher Education Institution Charter from NHERA.

Excellence in higher education could be achieved by Good Leadership to achieve the desired goals. Several universities used the 'Leadership sub criteria' as the entry point for selfassessment. The relationship between excellence and higher education is also an important one to be looked upon. The increasing understanding is that globalization is being reflected in an educational agenda that allows for various, and countless, improvements upon the education system that allows the educators themselves to expand on their teaching, and present students with real world situations that require them to "think outside the box", or outside the realm of their particular field. It is very important because as the students have to face the real world and they need to think different from the rest of the people with whom they will be competing and this could be achieved through excellence.

SUBMISSION GUIDELINES

- Researchers and Practitioners can submit their Papers exclusively on central theme and also they can submit papers specific to the track.
- The Abstracts should be no more than 250 words with Purpose, Methodology, Findings, Research Limitations, Practical Implications, Originality/ Value, & Key Words.
- The particulars regarding the title of the paper and author(s)'s name(s), designation(s), official address(es), phone/fax number(s) and e-mail address(es) should also be mentioned along with the abstract o6n a separate sheet for blind peer review.
- Papers should not exceed 10,000 words in length (all inclusive) with an abstract of no more than 250 words.
- Manuscripts in Microsoft Word (12 point Times New Roman font, double spacing and 1" margins on all sides).
- Follow formatting strictly as stated. Authors should include figures and tables within the text where they are intended to appear.
- All the accepted papers for presentation will be published in the proceedings.
